MEMBERSHIP DUES

- FULL
 - \$5000 -BILLED IMMEDIATELY. MUST BE PAID WITHIN 90 DAYS
- SEMI-ANNUAL
 - \$2600 - BILLED EVERY 6 MONTHS. MUST BE PAID WITHIN 60 DAYS OF BILLING
- QUARTERLY
 - \$1350 - BILLED EVERY 3 MONTHS. MUST BE PAID WITHIN 30 DAYS OF BILLING
- MONTHLY
 - \$500 - BILLED MONTHLY. MUST BE PAID WITHIN 15 DAYS OF BILLING

CART FEES

- TIER PACKAGE
 - IF THREE (3) OR MORE EMPLOYEES PURCHASE A TIER CART PACKAGE, A TIER CART PACKAGE (\$650 VALUE) WILL BE ISSUED TO THE CORPORATE MEMBER
- FULL PACKAGE

A COPORATE MEMBERSHIP WILL CONSIST OF:

- OWNER/OPERATOR OF SPECIFIED BUSINESS AND THEIR IMMEDIATE FAMILY
- FIVE (5) EMPLOYEES
 - THE EMPLOYEES WILL BE ISSUED A SINGLE MEMBERSHIP. THE EMPLOYEE CAN OBTAIN A FAMILY MEMBERSHIP BUY PAYING THE DIFFERENCE BETWEEN THE SINGLE AND FAMILY MEMBERSHIP (\$486). EACH EMPLOYEE WOULD BE RESPONSIBLE FOR THEIR OWN CART FEES, RANGE BALLS/RANGE PASS, BAG STORAGE, LOCKER RENTAL, MGA/WGA DUES AND HANDICAP FEES IF THEY CHOOSE TO UTILIZE THOSE SERVICES. PURCHASING CART PACKAGES ARE ALSO AVAILABE TO EACH EMPLOYEE.
